**Summer kWh Rates**

Effective during the months of June through September.

**Winter kWh Rates**

Effective during the months of October through May.

**Cost of Power Adjustment (PCA)**

Per *Policy BD-30: Energy Rate Design Guidelines*, any PCA from the wholesale power provider will be automatically passed through as a PCA to Polk-Burnett members.

**Taxes**

These rates and minimums do not include the Wisconsin and county sales tax, which must be added to each bill when applicable by law.

**Terms of Payment**

Payment is due when the bill is received. In the event the current bill is not paid on or before the due date, it becomes delinquent and the electric service is subject to disconnection. Any outstanding balance at the time bills are issued shall be subject to a late charge as defined by the fee schedule in force at the time.

**Controlled Loads**

The member will install, at their expense, the service entrance and appropriate equipment compatible with the Cooperative's SCADA and/or metering system. All controlled loads must be connected permanently to this separately metered circuit and the entire system available for inspection and monitoring at any time by Cooperative employees. Any fraudulent tampering with the off-peak system will result in the removal of the Cooperative's off-peak metering equipment and subsequently the off-peak rate.
