## 2018 Energy Efficiency Rebate Form

### ELIGIBILITY AND INSTRUCTIONS FOR COMPLETING THIS FORM *(Please read)*

- ❖ Rebate not to exceed 20% of the cost of efficiency equipment.
- ❖ Equipment must be purchased new and installed in 2018 on Polk-Burnett's lines.
- ❖ Rebates are in place through December 31, 2018 or until funds are depleted.
- ❖ Rebates will be issued as a check 8-12 weeks after approval.
- ❖ Submit the documentation listed below **no later than 3 months after the date of purchase or January 1, 2019, whichever comes first.** However, members are encouraged to submit as soon as possible to ensure rebate:
  - ✓ This rebate form
  - ✓ A copy of your dated receipt or invoice for each item purchased and a copy of the **AHRI certificate (REQUIRED)** and energy guide if available
  - ✓ If purchased anywhere but from a licensed heating / plumbing contractor a copy of the valid warranty must be included
