



Polk-Burnett joins co-op partnership to develop utility-scale solar in rural Wisconsin by General Manager Steve Stroshane

Nine Wisconsin electric cooperatives are working together to get the best volume pricing on solar energy for their members. They have formed a partnership with OneEnergy Renewables of Madison to develop 12 utility scale solar arrays across Wisconsin. Over the next two years, the partnership will add 22 megawatts of new solar generation. The arrays will generate enough electricity to power 4,000 homes for rural co-op members.

We are coordinating the timing of our local solar project with other cooperatives to get a better price and return on our investment for our members. The array on Polk-Burnett's system will be 2 MW; the total for all nine co-ops combined will be 22 MW.

Construction is set to begin in each co-op community in 2023 through 2024. The 12 solar arrays will be owned and operated by OneEnergy Renewables, and the co-ops will purchase the solar energy output at a fixed rate.

Cooperation among cooperatives is our guiding principle for this project. Wisconsin electric cooperatives are known for our work together to benefit members; for example, you often see co-ops assisting each other with storm recovery. This solar partnership will benefit our local membership by providing clean power at a long-term, stable cost.

Restoring native prairie

Co-op solar arrays are dual-purpose spaces that provide renewable energy for members, as well as acres of important ecosystems. The ground under all 12 arrays will be restored with prairie grasses and wildflowers, providing habitat for pollinators and healthy root systems to prevent soil erosion from wind and rain.

OneEnergy Renewables brings experience and expertise

OneEnergy Renewables is a leading solar energy company in Wisconsin that offers expertise in site development, engineering, equipment purchasing, construction and operations. The Madison-based team has developed 15 projects across Wisconsin, and another 11 in adjacent states.

GEORGETOWN SOLAR 2023

Georgetown Solar will become the second utility scale solar project in Polk-Burnett's service area. The array will be constructed in Georgetown Township, about 10 miles east of our Centuria office. The 15-acre site will have 5,148 panels that operate on a tracking system to follow the path of the sun for maximum power generation. The 2 MW solar array will generate about 4,500,000 kWh of electricity annually, enough to power 375 homes.

Georgetown Solar not only adds more clean energy to the grid, but it will also relieve overloading at substations and help offset power market costs.

Polk-Burnett supports a balanced transition to a lower carbon future.
We're gradually investing in local solar to become less reliant on volatile energy markets and strengthen grid reliability.

Polk-Burnett's first solar array, SunTuria Solar, was dedicated in 2017 behind the co-op office in Centuria. The 1.25 MW array generates power for about 200 homes. It is owned and operated by ENGIE North American, and the co-op purchases the solar energy output. We invite school and community groups to join us for a tour!

Watch for more about our local Georgetown Solar development this summer. We plan to break ground soon!

Good news! Members will see a PCA credit on electric bills this month

Your *credit* is based on the energy you use and reflects our *lower* cost to purchase power on your behalf.

A PCA is a Power Cost Adjustment on your electric bill. It can be a charge or a credit, depending on the power market. In late 2022, natural gas prices spiked and coal supply was limited, resulting in a higher cost of power.

The good news this spring: The price of natural gas has fallen and instead of PCA charges, Polk-Burnett will receive a PCA *credit* from Dairyland Power Co-op, our wholesale power supplier. We pass the PCA credit through to you.

As a not for profit cooperative, our rates are based on actual costs: they are not set to generate profit.

Annual herbicide notice for members Polk-Burnett's mission is to provide members with safe, reliable power as

Polk-Burnett's mission is to provide members with safe, reliable power as efficiently as possible. An important part of this mission is our right-of-way program, which includes herbicide application to control growth of woody stemmed vegetation under power lines.

In 2023, Polk-Burnett will continue its herbicide program to control vegetation in the electric right-of-way. Trained, licensed contractors will walk the rights-of-way with a backpack container and use a hand wand to apply a low-volume herbicide; only the leaves of woody stemmed vegetation are targeted. The application is scheduled to begin in June and will conclude in October.

If you choose to decline the use of herbicide, please complete and return form below by May 19 to: Polk-Burnett, Rights-of-Way Department, 1001 State Road 35, Centuria, WI 54824.

If form is not received by May 19, 2023, herbicide application may occur on properties not currently in our database.

IT IS NOT NECESSARY TO COMPLETE THIS FORM OR CONTACT US IF:

- 1) You are served by underground power lines. Polk-Burnett does not apply herbicide to underground lines.
- 2) You have already sent this form or contacted Polk-Burnett in the past to decline the use of herbicide. Visit polkburnett.com/herbicide-faqs to see if your property is already on the No Herbicide list.

Please do not apply herbicide on my property(s). I understand that if I have multiple properties where I do not want herbicide application, I must notify Polk-Burnett of all locations, so they can be properly identified. I understand that I must place signs (provided by Polk-Burnett on request) beneath the power lines to identify my property boundaries and that future right-of-way maintenance will be performed by mowing.
