### E-VEHICLE CHARGER ELIGIBILITY AND INSTRUCTIONS FOR COMPLETING THIS FORM (Please read)

- ❖ EV charger must be purchased and installed on Polk-Burnett lines in 2025.
- ❖ Charger must be a **LEVEL 2** charging unit.
- ❖ **Must be connected to load management.**  
\*\*Note: may include additional expense(s) – call Polk-Burnett for more details 800-421-0283 ext 319.
- ❖ May qualify for off-peak (*dual fuel*) rates.
- ❖ Rebates are in place through December 31, 2025, or until funds are depleted. Program subject to change without prior notification.
- ❖ Rebate Process:
  - 1) Purchase and install charger
  - 2) Once installed contact Polk-Burnett to make an appointment to verify hookup and install the load control device.
  - 3) Submit rebate form after 1 & 2 have been completed & before December 31, 2025.
- ❖ Rebate check will be issued 6-10 weeks after approval.
