### ELIGIBILITY AND INSTRUCTIONS FOR COMPLETING THIS FORM (Please read)

- ❖ Equipment must be purchased & connected to Polk-Burnett's grid in 2026. PV solar equipment must be UL listed.
- ❖ A site assessment is strongly recommended
- ❖ System needs to be inspected by a commercial electrical inspector prior to Polk-Burnett coming out to install the NET meter.
- ❖ Rebate for solar projects are capped at \$750 per account.
- ❖ Rebates are in place through December 31, 2026, or until funds are depleted. Program subject to change or cancellation without notice.
- ❖ It is the member's responsibility to make sure all detailed documents required for the rebate are submitted correctly prior to the end of the year.
- ❖ All charges from Polk-Burnett must be paid prior to the rebate being issued.
- ❖ Rebate will be issued as a check **6-10 weeks after approval** and after all invoices from Polk-Burnett related to the solar installation are paid.
- ❖ Submit copy of this rebate form and copy of your detailed invoice **Within 3 months after grid connection or January 1, 2027, whichever comes first.** However, members are encouraged to submit as soon as possible to ensure rebate:
  - ✓ This completed rebate form
  - ✓ A copy of your dated, detailed receipt or invoice. **Must be an actual invoice which includes the size of the system, the brand name & complete model number of the panels that were installed, and the cost of the project. (proposals, bids, estimates, and contracts will not be accepted for rebate submission)**
