## Polk-Burnett joins CHARGE EV

Regional electric vehicle charging network will help alleviate range anxiety, encourage EV adoption in rural communities *by General Manager Steve Stroshane*

Polk-Burnett is one of 31 electric cooperatives that have come together to form a regional EV charging network across Wisconsin, Minnesota, Iowa and Illinois. CHARGE EV, LLC, was created to help co-op members with the adoption of electric vehicles in rural communities.

While we don't expect transportation to change overnight, we created the charging network to help prepare for future growth in EV use. We want to be a trusted resource for members considering an EV.

EVs have environmental advantages and can help members save money through reduced fuel and maintenance costs. Moving from gas to electricity reduces pollution, and the benefit improves as the electric grid gets greener. We support EV owners and look forward to working with members to charge your e-vehicles in the most cost-effective way. *Please call us before installing an EV charger at your home.*

Currently, we are aware of 36 EVs plugged into our system for residential charging, and our service territory has a handful of Level 2 public chargers, including one powered by Polk-Burnett at Marketplace on Hwy. 8 in St. Croix Falls. We know that range anxiety is a concern that some of you may have about driving an EV. Our efforts with CHARGE EV will help alleviate that fear by investing in charging stations and helping our members with residential chargers. Presently, the CHARGE EV network includes more than 30 Level 2 and Level 3 charging stations, with more on the way.

### Investing in the future with ZEF Energy

CHARGE EV cooperatives recently invested in ZEF Energy Inc., an Edina, Minnesota, company that manufactures EV chargers with ZEFNET software to manage energy supply.

ZEF Energy has successfully worked with electric cooperatives since 2014. The company is also working with the U.S. Department of Energy on the Michigan to Montana (M2M) project, which will install ZEF Energy chargers along the I-94 corridor.

"Cooperatives are forward thinking organizations and they recognize that EVs will play a big part of their future," said ZEF Energy CEO Matthew Blackler.

Our regional CHARGE EV network and investment in ZEF Energy are just the start. We hope this grows into a national co-op EV brand and charging network.

"Our goal is to provide EV owners with peace of mind when driving between Wisconsin, Minnesota, Iowa and Illinois, knowing that there are co-op powered chargers along your route. That will give people confidence to consider an EV and encourage growth of electric vehicles," said Jeff Springer, manager of innovation and efficient electrification at Dairyland Power Cooperative, our G&T power supplier.

Watch for updates about Polk-Burnett's participation in CHARGE EV, as well as rebates and incentives for residential charging, and new public charging stations across the region.

## Building or landscaping this spring? Call before you dig

Call before you dig.**

April is national Safe Digging Month. Before you build a deck, install a fence, plant a tree or dig into any home improvement project, have utility lines marked. One call helps protect you from injury and expense.

## Annual herbicide notice for members

Polk-Burnett's mission is to provide members with safe, reliable power as efficiently as possible. An important part of this mission is our right-of-way program, which includes herbicide application to control growth of woody stemmed vegetation under power lines.

In 2021, Polk-Burnett will continue its herbicide program to control vegetation in the electric right-of-way. Trained, licensed contractors will walk the rights-of-way with a backpack container and use a hand wand to apply a low-volume herbicide; only the leaves of woody stemmed vegetation are targeted (see photo above). The application is scheduled to begin in June and will conclude in October.

*If form is not received by May 21, 2021, herbicide application may occur on properties not currently in our database.*

- 1) You are served by underground power lines. Polk-Burnett does not apply herbicide to underground lines.
- 2) You have already sent this form or contacted Polk-Burnett in the past to decline the use of herbicide.

Please do not apply herbicide on my property(s). I understand that if I have multiple properties where I do not want herbicide application, I must notify Polk-Burnett of all locations, so they can be properly identified. I understand that I must place signs (provided by Polk-Burnett upon request) beneath the power lines to identify my property boundaries and that future right-of-way maintenance will be performed by mowing.
