# We're returning **\$1,010,000**: If you purchased power in 1990, 1996 and/or 2015, you'll get money back

I'm pleased to report that Polk-Burnett Electric Cooperative will return more than \$1 million this year in Capital Credits, including \$860,000 to co-op members who purchased electricity in 1996 and/or 2015, plus a Capital Credit retirement of about \$150,000 from Dairyland Power Cooperative, our wholesale provider, to members who purchased power in 1990.

It pays to be a co-op member: 16,504 active members and 7,050 former members will receive Capital Credits in September. Capital Credits are a benefit of your co-op membership! Any money left after expenses is returned to members, according to our co-op principles. WATCH FOR CREDIT ON YOUR SEPTEMBER BILL! (In past years, members received a check in the mail.)

7 tips for a safe harvest: Keep farm equipment clear of power lines 1) Use a spotter when operating machinery near power lines.
2) Use care when raising augers and truck beds near power lines.
3) Keep equipment at least 10 feet from power lines.
4) Inspect height of farm equipment and know clearance.
5) Always lower extensions when moving loads.
6) Never move a power line out of the way or raise it for clearance.
7) If a power line is sagging or low, call us at 800-421-0283.

If contact is made with a power line, stay inside the equipment. Warn others to stay away and call 911. Do not exit until the utility crew says it is safe. The only reason to exit is if the equipment is on fire. In this case, jump with feet together, then hop away. Do not touch ground and equipment at the same time.

## **Keeping the right-of-way clear for reliable power and safety** The right-of-way (ROW) is a strip of land under power lines. The co-op has the *right and responsibility*

to clear vegetation in the ROW that may disrupt your electric service or cause harm to people.

Keeping power lines clear of trees and brush reduces power outages and blinks, and gives linemen better access to maintain and repair power lines.

ROW clearing also improves safety for your home and family, and helps prevent forest fires by ensuring that tree branches do not become energized due to contact with power lines.

Power lines carry high-voltage electricity that can be dangerous-even deadly. Never trim a tree in the ROW or near power lines, and do not allow kids to climb trees close to power lines.

Polk-Burnett employees and contractors will work throughout the fall to maintain a clear right-of-way.

#### If you see vegetation near power lines that needs to be trimmed or removed, please contact us.

Are you planting this fall? Installing a fence? Or building a deck? Before you dig into any home improvement project, have utility lines marked. One call helps protect you from injury and expense.
