## **BUDGET PLAN**

- Price per gallon is always \$0.05 less than the current truck price and this year's capped price is \$1.59/gal.
- You must either have a credit or zero balance at time of enrollment.
- You must have at least a 250-gallon tank or larger and get at least two deliveries per year.
- You will automatically be removed from the plan by missing two consecutive monthly payments- any balance plus finance charges will be due at that time.
- Monthly payment amounts are based on your previous year's usage divided by 12 months (any credit/due amount on account is figured into calculation).
- Budget plan enrollment is subject to approval and certain restrictions may apply.
- Budget plan cannot be used for pre-buy contracts.
- Accounts will be periodically reviewed and amounts may be adjusted to avoid large catch-up amounts due in July.
