2018 Energy Efficiency Rebate Form

ELIGIBILITY AND INSTRUCTIONS FOR COMPLETING THIS FORM *(Please read)*

- ❖ Rebate not to exceed 20% of cost of new appliance except for recycling.
- ❖ Appliance must be purchased in 2018 and installed on Polk-Burnett's lines.
- ❖ New or recycled appliances must be electric.
- ❖ Rebates are in place through December 31, 2018 or until funds are depleted.
- ❖ Rebates will appear as a one-time **credit on your electric bill** within 1-3 billing cycles after approval.
- ❖ Submit the documentation listed below **no later than 3 months after date of purchase or January 1, 2019** **whichever comes first.** However, members are encouraged to submit documents as soon as possible to ensure rebate.



- ✓ This rebate form
 - ✓ A copy of your dated receipt or invoice for each item purchased
 - ✓ Yellow Energy Guide, copy or original, showing the ENERGY STAR symbol for each item purchased
 - ✓ For recycled appliances, include receipt and de-manufacturing form for each item.
- Dehumidifiers will not have Energy Guide.
